

DECLARATION FOR WIDOW'S PENSION.

Act of May 1, 1920.

State of Pennsylvania, County of Columbia

On this 8th day of FEBRUARY, 1923, personally appeared MARY ARNER before me the undersigned, who makes the following declaration as an application for pension under the provisions of the act of Congress approved May 1, 1920.

That she is 72 years of age, that she was born October 25th, 1850 at Germany, and that her post-office address is Berwick, Penna.

That she is the widow of Hiram Arner, who ENLISTED October 27th, 1862, at Hiram Arner, in Company "C" 178 Pa. Draft Militia (Here state company and regiment, if in the Army; or vessel, if in the Navy.) and was honorably DISCHARGED July 27th, 1863, having served ninety days or more, or was discharged for, or died in service of the United States of a disability incurred in the service in the line of duty, during the CIVIL WAR, and who DIED January 21, 1923, at Neacopeck, Penna.

That he also served in None (Here give a complete statement of all other military, naval, or coast guard service, if any, at whatever time rendered.)

and that, except as herein stated, said soldier (or sailor) was not employed in the military or naval service of the United States;

✓ THAT SHE WAS MARRIED to said soldier (or sailor) June 7th, 1900, at Dushore, by Rev. John W. Klingler

that she had not been previously married, that he had not been previously married; That she was NOT divorced from the soldier (or sailor) and that she has NOT remarried since his death; That the following are the ONLY children OF THE SOLDIER (or sailor) who are now living and are under sixteen years of age; (If he left no children under sixteen years of age, the claimant should so state.)



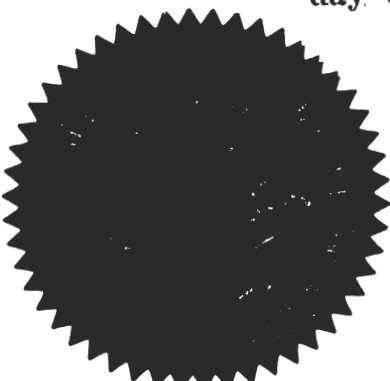

Madam:

In response to the inquiry of J.P. Hayman, of Berwick, Pa., I have to advise you that your above entitled claim requires a verified copy of the public record of death of your former husband, John Lenhart, and of soldier's former wife, Sarah E. If no such records exist, there should be furnished the affidavit of the attending physician, showing the date or approximate date of death in each case; or, if that cannot be obtained, the affidavits of two persons present at each death or burial, or having personal knowledge of the death.

The affidavits of two witnesses, who have personal knowledge of the facts in each case, should be furnished showing whether you remarried after the death of your former husband and prior to your marriage to the soldier; also whether soldier remarried after the death of his former wife and prior to his marriage to you, showing the dates in each case. The affidavits of W.H. Gibbs and Lulu Hoffman, relative to your prior marriage, cover only the period prior to your first marriage, as also those of Mary R. Hinkle and Nathan Fry, cover only the period prior to soldier's first marriage.

Your own sworn statement is required showing your name at marriage to the soldier.

No affidavit can be considered satisfactory that fails to state affiant's age, post office address, and means of knowledge of the facts stated.

Do not fail to inscribe on each paper furnished the

name and service of the soldier and the number of the claim to which it relates.
